Appendix a

The Open Saces team have repaired the manhole in the car park at Coubro. Thanks to one of them for supplying the manhole.

The roofer is rodding the guttering as when the manhole was repaired, it was partially blocked with stones from the car park.

I have tried to find a structural engineer who tests for RAAC, apparently there are only a few specialist companies in the UK that carry out this testing. I have been recommended to one in Lincoln but, as of the time of writing this, I haven't heard back from them.

Regarding the Chapels Spire, this is not something that a regular structural engineer will take on. We will need to approach the company that carried out the previous survey.

I have managed to get one quote for the asbestos surveys for Coubro, pavilion, toilets, tractor shed and cemetery chapels.
