Ex gratia payments are, therefore, gestures of goodwill on behalf of the employer outside of your contract of employment.

The HMRC payment in the latest expenditure is also significantly increased to £4,097 which I'm guessing is linked. Salaries from September 2023 have increased as we employed a new Deputy Clerk and an Apprentice.

I've also included a shot of our drainage mapping from the highways asset management system we use (Confirm). The blue lines are representations of surface water (highways) drainage pipes, the squares are gullies and the triangles are offlets. Obviously this is quite zoomed out as it's a live mapping system which covers all of Lincolnshire rather than individual files. However I'm happy to provide zoomed in captures of specific areas of interest if requested.

Utilities including Anglian Water hold their own drainage mapping, sometimes private and highways drainage connects into their combined systems but this is where they'll hold detailed records of clean and foul water systems in the roads. I raised this with you at the last meeting of the full council meeting on the 14th April 2025 at the Methodist Hall. It would seem that the committee and the deputy clerk have deliberately excluded you from seeing this item and at the full meeting one of them should advise you of the request.

I request (FOI REQUEST) to be advised who raised this? Was it on the agenda? Why is it required when the Clerk has years of experience on this type of work? Looking at the budgets I cannot find anything. I would presume that the daily costs for each person would be in the region of £750 per day. This estimated cost does not seem to have been included in the budget for the rebuild of the bungalow so (FOI REQUEST) how are these costs going to be paid for?

(2) Item 2. Open Spaces committee meeting held on the 25th March 2025. Minute item 6 is a request to purchase an anti bench. Who (FOI REQUEST) requested this? What is the proposed cost? This does not show in the list of projects for 25/26 so where will the funding come from?

(3) Item 3. To spend up to £5,000 on a second hand van. In the video recording the chair of the council stressed that this is needed asap to enable the staff to be able to work. I remember discussing this issue some years ago which led to the purchase of a proper trailer with the idea that if the staff need to take any equipment to sites out of Holbeach.

Again, despite being 14 days into the financial year that the chair of finance seems to want to spend money on projects that have not been included in this years budget.

(4) Item 4. To purchase pre paid credit cards up to £100. This was stopped some yeas ago and a procurement policy which stated that nothing can be purchased without an authorised purchase order. Most of the Parish companies in Holbeach do already have opened accounts for the open spaces team. I note that this is required in case you are away. I also believe that the deputy clerk does have access to the purchase ordering record.

Decision:

- (1) This item was discussed at the PPES meeting of the 1st April 2025 but was not an agenda item. It will be on the next PPES agenda to instruct a project manager. The Clerk does have years of experience as a project manager however, there is new legislation and in order to comply with this, the PPES Committee will come to a decision on the option of contracting a project manager. The cost you have quoted is incorrect for the this type of project management. The cost will be born from the Property Project budget in the same way the planning application was.
- (2) The purchase of an anti-vandal bench was decided by the Open Spaces Committee. It is a replacement bench and came out of the street furniture budget.
- (3) There have been changes which are now necessitating the purchase of the vehicle. It will be used to tow the trailer. The cost is in the budget under Machinery and Plant renewals. We also have an Ear Marked Reserve of £6,000 Plant & Machinery Fund
- (4) Staff have not previously had pre-paid credit cards. In the Clerk's absence, the Deputy Clerk has no way of making emergency purchases as it is only the Clerk that has a Credit Card. The Open Spaces team will have cards with a preloaded amount of £100. New Financial Regulations have been issued by NALC which now include the procurement and therefore the Council has voted to withdraw the Procurement Policy as this is in the Financial Regulations Policy.
