#### PP24/5-101 Speeding

 To resolve to agree the SID locations for March
To receive an update and to resolve to agree a response on the new speed limit signs on Fen Road.
To resolve to agree a response to an email received in regard to speeding on Barrington Gate.

Dear Holbeach Parish Council,

I hope this email finds you well.

I wish to raise concerns regarding the excessive speeding of motor vehicles on Barrington Gate, PE12 7LB.

My family has lived at for over 10 years. We moved to Holbeach due to the low crime rate and its strong sense of community.

Over the last three years, there has been a noticeable increase in speeding on the aforementioned road. In this time, four parked vehicles - two owned by my family - have had wing mirrors broken due to reckless driving.

On 2 February 2025 alone, there were two motor accidents on Barrington Gate. The first, published on Spotted Holbeach Facebook Group and the second incident, witnessed by my sister.

It is highly likely that a bad accident will happen in the near future; resulting in serious injury, death or extensive damage to a property on the road.

Should a Local Authority fail to implement adequate measures to control speeding, they can be found liable in civil proceedings if an accident is caused by speeding.

The two Speed Indicator Devices (SID'S) that Holbeach Parish Council own are, unfortunately, an inadequate measure to manage speeding. They are rotated around the Parish on a monthly basis and dangerous speeding on Barrington Gate occurs on a daily basis.

Please consider implementing a permanent solution for the management of traffic speeds:

1. A speed camera, in partnership with Lincolnshire Police, would be an effective source of revenue for Holbeach Parish Council and act as a deterrent for dangerous and reckless driving.

#### 2. Signage with the speed limit.

3. Speed bumps.

4. The Community Speed Watch (CSW) Scheme.

1st Email Dear Sir/ Ma'am,

I am emailing regarding the excellent work from all councils regarding reduction of speed limits on the B1166 through Shepeau Stow and Holbeach Drove.

I do believe there is more to be done however.

The speed limit through Holbeach Drove, currently a 40, does appear to be too fast. Especially when you consider a busy garage and village shop on the corner of what is also a busy junction. I feel there is perhaps scope to reduce this.

I also feel that speed limit should be reduced further down Holbeach Drove gate. Having lived on the Main Road for many years now I am in a prime position to state that a 50 limit practically does nothing for traffic calming and some of this section also needs a reduction.

I hope you find this email of some use for stating an case and shows a potential need for further speed reductions in the area.

2nd Email

Hi, I live in Holbeach Drove Gate PE12 0PX & I am getting more & more worried about the speeding traffic past my home.

I am aware that a survey has been carried out in Holbeach Drove but it was not carried on to Holbeach Drove Gate. I am also aware that a survey had been asked for by \*\*\*\*\*\*\*\* in both Drove & Gate.

After many incidents along this road, including fatalities, electricity poles being knocked down by traffic, resulting in power cuts, & recently an accident opposite my home with a stone wall being driven through by a speeding car & ending up in the front garden, after going through pampas grass & tyres. Also including lorries leaving the road to avoid oncoming traffic.

We have residents in Holbeach Drove gate afraid to walk on this road let alone cross it due to the extortionate speed of vehicles, including a lady in an electric wheelchair.

To get to the bus stop in Holbeach Drove I have to walk on the road as we have no pathways & it's very scary as some seem to use our road as a race track.

I have lived in Holbeach Drove Gate for around 9 years, the speeding is getting worse & I feel something needs to be done to slow down vehicles as has been done on Hulls Drove & Shepeau Stow.

I started a Facebook page to discuss this fact on Monday & already have 15 members who are also concerned about speeding in Holbeach Drove Gate.

A survey would be very much appreciated by all concerned before more accidents/incidents/fatalities occurs.

8. To resolve to agree a response to an email received in regard to speeding on Star Lane, Holbeach Bank.

Hi, I am growing increasingly concerned about the speeding traffic along Star Lane, Holbeach Bank. School times are particularly bad with parents who you would expect to adhere to the 30mph limit ignoring it.

One of the worst is the taxi mini bus drivers fetching the children.

I have emailed the taxi company regarding this but nothing has changed.

With children walking along Star Lane and parked cars it's a concern that accident will happen. The 30 mph limit sign is only about 20 meters from the first house in the village and think it would be better moved further along the lane to slow vehicles down before the houses.
