From a parishioner:

I understand that the cemetery is a public space, and we have signs there about dogs being on leads. There seems to be a growing number that are off leading their dogs and throwing balls and exercising the dogs there. It's not really the place for this kind of activity.

Can you please pass this on to open spaces as this will become a problem, not only for the people tending to graves but also the dogs are going to mark headstones (if its a boy) and also leave deposits that the owners have not noticed while their dog is off lead.

Holbeach Hurn

We have received a couple of complaints from a parishioner at Holbeach Hurn regarding grass cutting and saving that the grass has not been cut in three weeks. I have checked with the contractor and the grass has been cut weekly. On the 19th of October, the contractor went to do the weekly cut and a square has been cut very short by some person. Our contractor reports that they believe this square to have been cut by the person who plays golf on the playing field as there are quantities of golf balls left on the playing field. This would be costly to the contractor if they were to damage his machinery. We have photos.

Allotments

We have the new allotment signs, and they are waiting to be put up. The allotment invoices have all gone out.

Following the comments made at the last full council meeting regarding the allotment rent, the original agreement from 2013 did state rent in advance, however two previous Clerks before me had charged the rent in arrears. I have sent a letter to the gentleman concerned along with previous invoices and asked why this was not raised before. The legislation is the Allotments Act 1950 section 10, which states: if the yearly rent exceeds twenty-five shillings (£1.25) then it is not permissible to provide for more than one guarter's rent to be payable in advance. Although this is not legally compliant, if both the tenant and the allotment authority make an agreement at the beginning, the rent may be payable in advance. If the gentleman wishes to pay in advance, then we would need to have confirmation from him and the rent would be more next year as a president has already been set with paying in arrears.

The large plot is ready for ploughing and I am waiting to hear when that will be.

Tree work

We need to give notice to work on the trees as most of them are in a conservation area. I have now spoken to the lady and have completed the paperwork.
