I'll have to be honest and say that there might be a delay on this as they have quite a backlog of issues to deal with, but hopefully – as it's been put through as a Road Safety project – it will have some priority.

LCC Crowland Division have been in touch as they are being visited by an executive who will be looking at the issues of the surrounding roads and they have asked if we have any to report, I informed them of that the road is seriously eroded on the Holbeach side and Sutton St James side of Saturday Bridge.
