### **Clerks Report**

## Speeding

St Marks - We have received confirmation from LRSP that there is no funding available from CSW as the project is really something that Parishes fund – as per our reactive battery signs.

Cost wise, a wired in unit would be about £6,000 but it would be fixed. It's not something that LRSP would support as there is no collision history. The best option that they recommend would be to use your battery units and move them around.

### **Properties**

**Chapels** - A full set of accounts both for the charities and limited company have been requested.

Bowling Green - We have contacted the Bowling Green to inform them that we will continue to complete the maintenance schedule they provided as much as we can and they have let us know that they are still happy to use the green before the beginning of the season so we can plan out our workload. Their fixture list has now been received.

Telephone Box, High Street, Holbeach - The defibrillator funded by Chosen has been installed and registered with the Emergency Services.
