A member of the public asked about the drainage drawings that were promised following the Boston Road sink hole meeting, Cllr S Hutchinson explained they had still not been received.

A member of the public queried that the precept had gone up over 50% in ten years but the number of councillors has dropped. It was explained that there were more projects now than ten years ago and if the precept was calculated by the rate of inflation, year on year over the last ten years, then it has kept pace with inflation. With the increasing costs of energy, this has caused a rise in budgets. Delivering large scale projects, they could be sponsored. This year there has been an underspend which will go back into reserves which is needed. It was explained what the reserve levels should be.

A member if the public asked what is being spent in the villages, the reply was that the villages have not asked for anything. There was a request for a planter and by working together, this had been achieved.

A member of the public asked if the bench at one of the villages could be repaired, the Council's Clerk will look int this.

A member of the public asked about a report in the Spalding Voice that said that you can "get all this for 2.6p"? It was explained that this represents the projects based on a band D property, they asked what is the chart?, it was explained that it showed how much we spend, it includes income, the full
