Mrs Hutchinson said that she had raised a formal complaint (The Clerk had acknowledged this) and she wants an apology regarding the condition of Park Road Cemetery. Cllr R Flood stated that it had been started but not completed. Cllr M Murfet said that the previous Open Spaces Committee had instructed our Open Spaces team not to cut Park Road Cemetery but to focus on Carters Park. Members of the public believed we were following "no mow May", this is not the case. Cllr R Flood explained the situation to Mrs Hutchinson that it was not the contracted area of

our contractor and that our Open Spaces team would concentrate on Park Road cemetery beginning tomorrow. It was **resolved** to agree to meet with the contractor.

- b) It was **resolved** to agree to move to weekly grass cutting by the contractor.
- c) It was discussed and **resolved** to agree a grass cutting schedule for the Open Spaces team as to concentrate on Park Road cemetery until it was back to its respectful condition.

All Saints Churchyard

Again issues around grass cutting. The area to the side of the church by the graves is always left wild until the bluebells have finished flowering. Our Open Spaces team report this area is also full of baby ducklings.

Netherfield

Again complaints received regarding the grass cutting. One email received about opening the vehicular access, replied explaining a previous survey had unanimously resulted in the decision to keep them closed.

Hall Gate

Again complaints received about grass cutting. There are vehicles that are parking on the access road, this restricts access coming from Netherfield direction, although no funeral directors have flagged this up.

Our Open Spaces team have began tidying the garden area.

Nature Reserve

The duck food machine has been reinstalled following its removal over the winter.

Holbeach Bank Playing Field

Again, grass cutting issues. The bench needs repainting.

Other maintained areas

All areas have problems with grass cutting. We have received a message to say that at Holbeach St Marks a local farmer has cut the playing field. At Holbeach St John's churchyard there has been a couple of complaints about not cutting at the back.
